Contract of Agreement

THIS AGREEMENT is entered into

WHEREAS, the VOLUNTEER is prepared to provide services as follows: assist park staff

WHEREAS, the VOLUNTEER agrees to provide the above services at the following times:

As needed or scheduled with the FOBCSP.

and

WHEREAS, the DIVISION agrees to provide supplies, training, evaluation as needed to perform duties.

The VOLUNTEER agrees to wear the volunteer hat or visor and/or ID badge as official uniform.

WHEREAS, in consideration of the mutual benefits to be obtained, the DIVISION and the VOLUNTEER do hereby mutually agree as follows:

The DIVISION, through the Chief of the Division of Parks and Watercraft or his designee, shall decide on all questions which may arise as to quality, fitness, promptness and acceptability

of service provided by the VOLUNTEER and therefore the Chief or his designee may void or cancel this agreement by giving written notice to the VOLUNTEER, thereby voiding or canceling said agreements and his determination and decision shall be final and conclusive. The VOLUNTEER may cancel this agreement at any time, for any reason by giving notice to the park manager.

VOLUNTEERS are persons who are considered employees of the state of Ohio only for the purposes enumerated in Section 1501.23, Chapter 4112 and Chapter 4123 of the Revised Code. They are not considered a state employee under Chapter 124 of the Revised Code and will not be to participate in any public retirement program and are not eligible for benefits under Chapter 4141 of the Revised Code.
